FIRST AID

Have the product container or label with you when calling a poison control center or doctor, or going for treatment. This product is not to be used as a terminal sterilanthigh-level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally serile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or ordinarily serile areas of the body.

DISINFECTION, DECODRIZING AND CLEANING - Remove visible soil prior to application of the product. Hold container six to eight inches from surface to be treated. Allow product to wet the hard non-porous surface for 3 minutes (for Bloodborne Pathogens: allow surface to remain wet for HIV-1 1 minute and for HBV and HCV 1 minute). No scrubbing is necessary. Wipe off with a clean cloth, mop or sponge. The product will not leave ent or soan scum.

One-step* cleaning and disinfection of toilet bowls and urinals: Remove water from bowl by forcing water over trap with a swab mop applicator.
